# Health Equity Guide

The Division of Environmental Health Science and Practice (DEHSP) established the Vital Conditions Mission Coordination Team (VC MCT) in October 2021. VC MCT developed a health equity strategic plan to outline the activities DEHSP will carry out in support of CDC's CORE Health Equity Science and Intervention Strategy. DEHSP selected the Vital Conditions for Health and Well-Being Framework to drive this plan. This infographic provides an overview using accessible language for the DEHSP Vital Conditions Health Equity Plan.

# DEHSP addresses health equity in the following ways

- Investigates how the built environment impacts health equity
- Tracks and analyzes how policies influence systemic and social factors
- Directs interventions toward communities with higher exposure to environmental health inequities
- Integrates social determinants of health (SDOH) indicators in surveillance, interventions, and research activities
- Increases engagement among Indigenous communities and populations at greater risk
- Increases collaboration with non-traditional partners (e.g., transportation)
- Expands the evidence base on reducing health disparities and environmental injustices
- Develops guidance for respiratory health equity



# What is the Vital Conditions for Health and Well-Being Framework?

- A model that prioritizes Health in All Policies (HiAP)
- Domains include 7 community-identified social determinants of health
- An approach aligned with Healthy People 2030 and CDC Social Determinants of Health Framework

# Health Equity is defined as...



The attainment of the highest level of health for all people. Achieving health equity requires valuing everyone equally with focused and ongoing societal efforts to address avoidable inequalities, historical and contemporary injustices, and the elimination of health and health care disparities.

#### Environmental Justice is defined as...

The advancement of health equity and elimination of environmental health disparities through the fair treatment and meaningful involvement of all people in environmental health policies, research, and programs, and ensuring equal access to a healthy environment.

Health equity, environmental justice, and DEIAB efforts make up the focal points of the DEHSP three-pronged approach. This is a transformative shift from monitoring disparities to investigating the indicators of a thriving community. This will foster resilient and thriving communities. Each prong represents a unique facet of DEHSP's mission to achieve optimal environmental health for all communities.
