Percent of Additional Cases ID After 3 Months but Before 6 Months: # Additional Cases ID After 3 Months but Before 6 Months of Age / Additional Cases of Hearing Loss *100

Percent of Additional Cases ID After 6 Months: # Additional Cases ID After 6 Months of Age / Additional Cases of Hearing Loss *100
