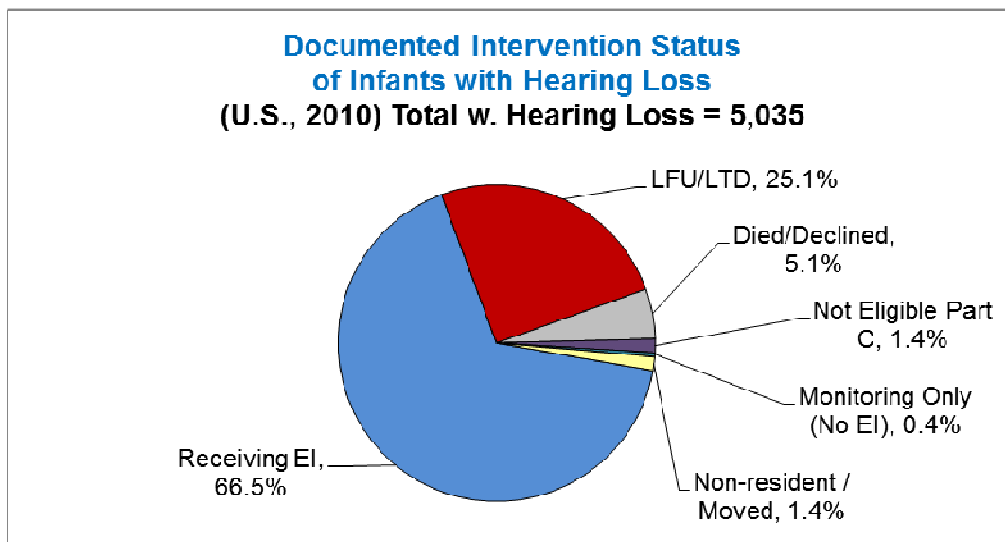
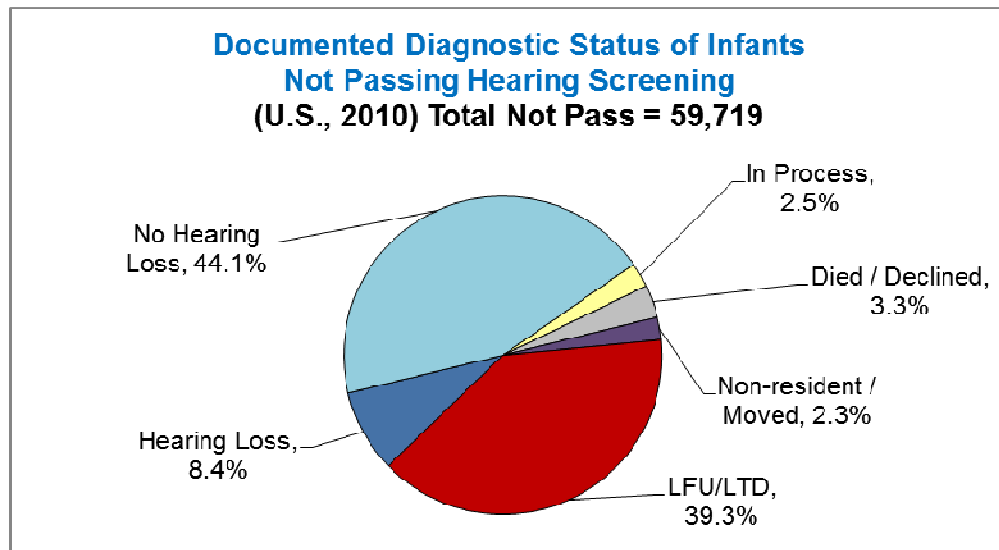
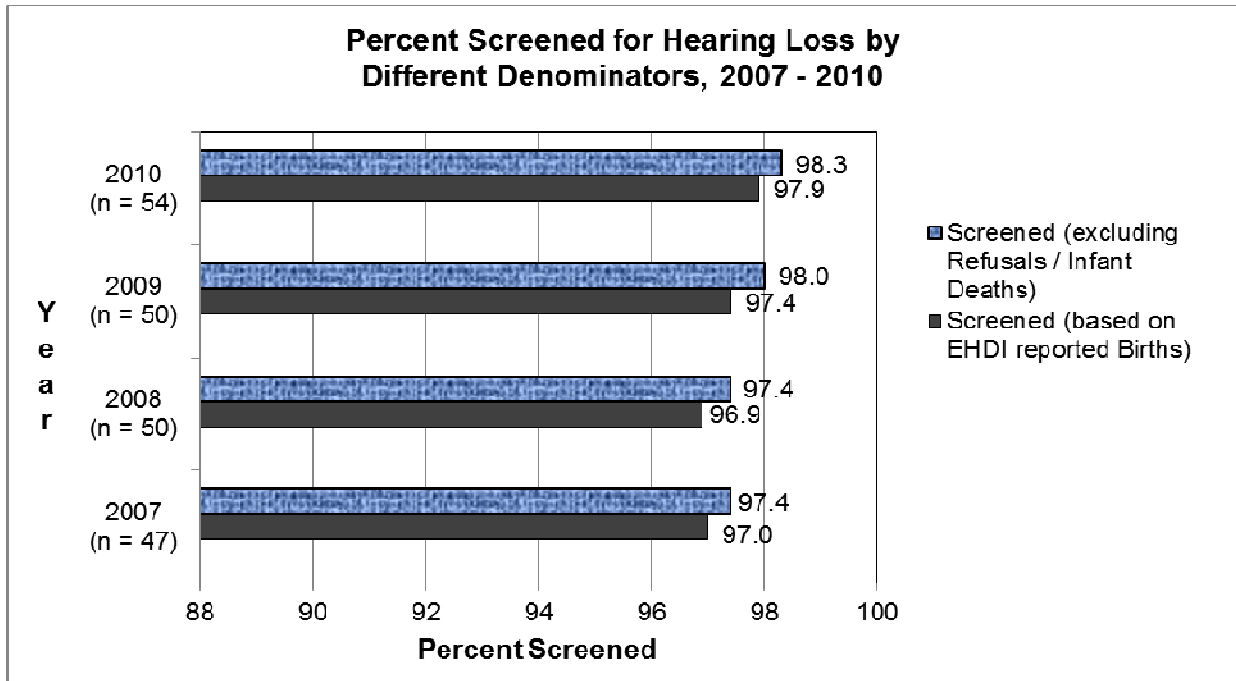

Data Notes

- HSFS data reflects information that states and territories have reportedly **documented** without estimation. As a result, data reported by CDC EHDI may differ from other sources.
- Some respondents **only** provided partial data (e.g. hearing screening data only). As a result the number of reporting states and territories and denominators varies for some of the data sections.
- This data is subject to change if additional states and/or territories report data for year 2010.
- **In Process:** Respondents were advised that to be reported in this category each infant **must** have been seen for diagnostic testing at least one time and have a follow-up appointment already scheduled.
- **LFU (Loss to Follow-up) / LTD (Loss to Documentation):** Sub group of “No Documented Diagnosis / Undetermined” and “No Intervention Services.” Includes instances where infant’s families were *Unable to be contacted or Unresponsive.* and *Unknown cases.*

Documented Hearing Screening (based on data from 54 States & Territories)

Percent Screened

3,881,048 (# screened) / 3,965,744 (occurrent births reported by EHDI programs) x 100 = 97.9%

Percent Screened (excluding infant deaths & parental refusals)

3,881,048 (# screened) / 3,946,837 (occurrent births excluding infant deaths & parental refusals) x 100 = 98.3%

Percent Screened Before 1 Month of Age

3,605,048 (# Pass and # Not Pass before 1 Month of Age) / 3,881,048 (# Pass + # Not Pass) x 100 = 92.9%
