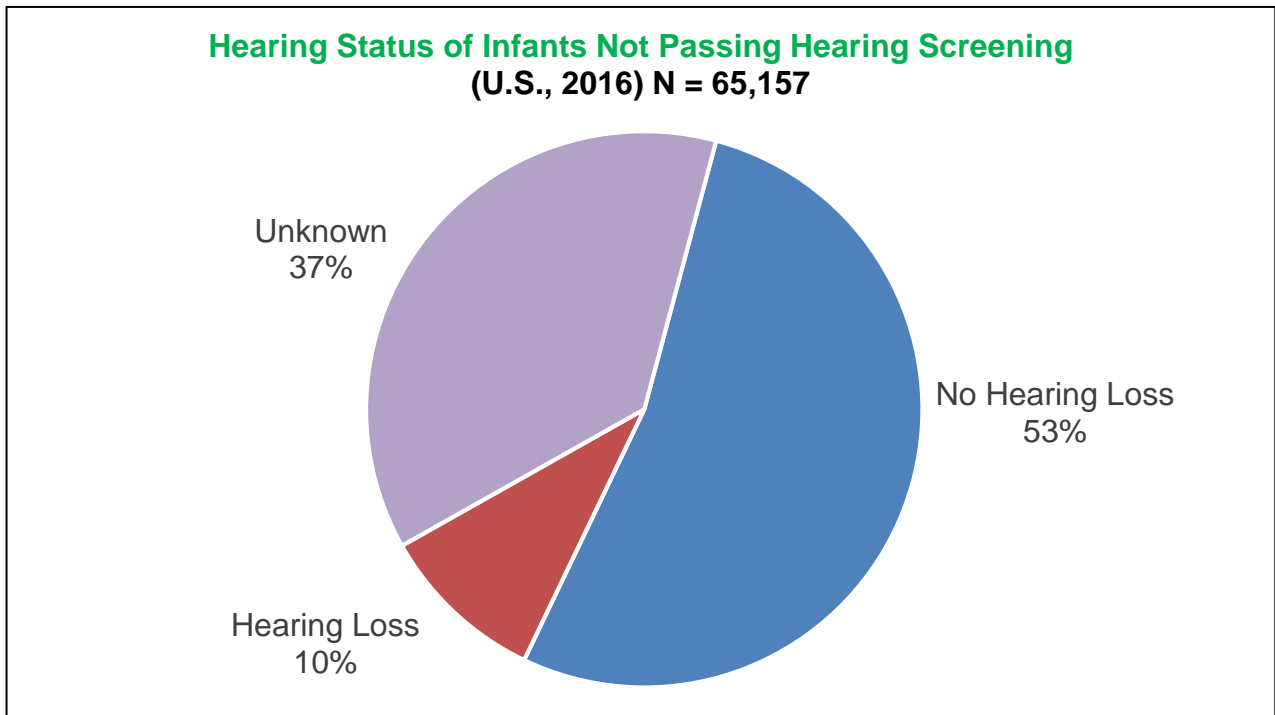
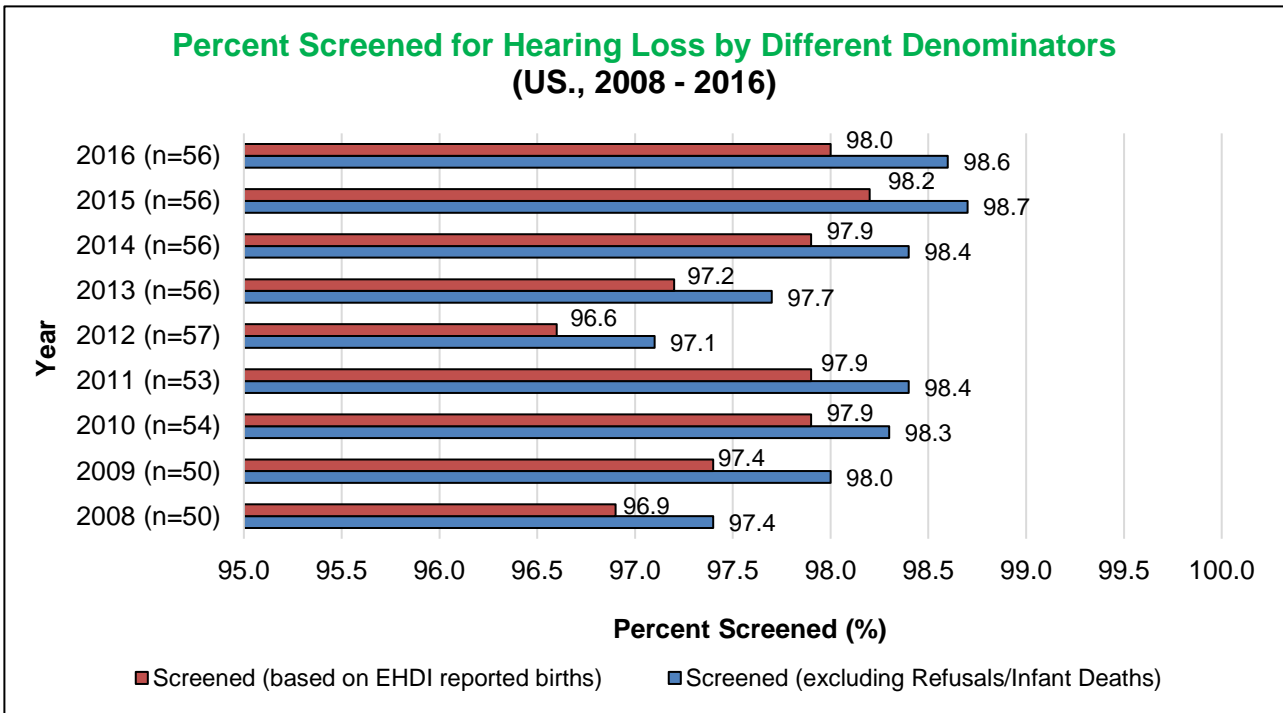

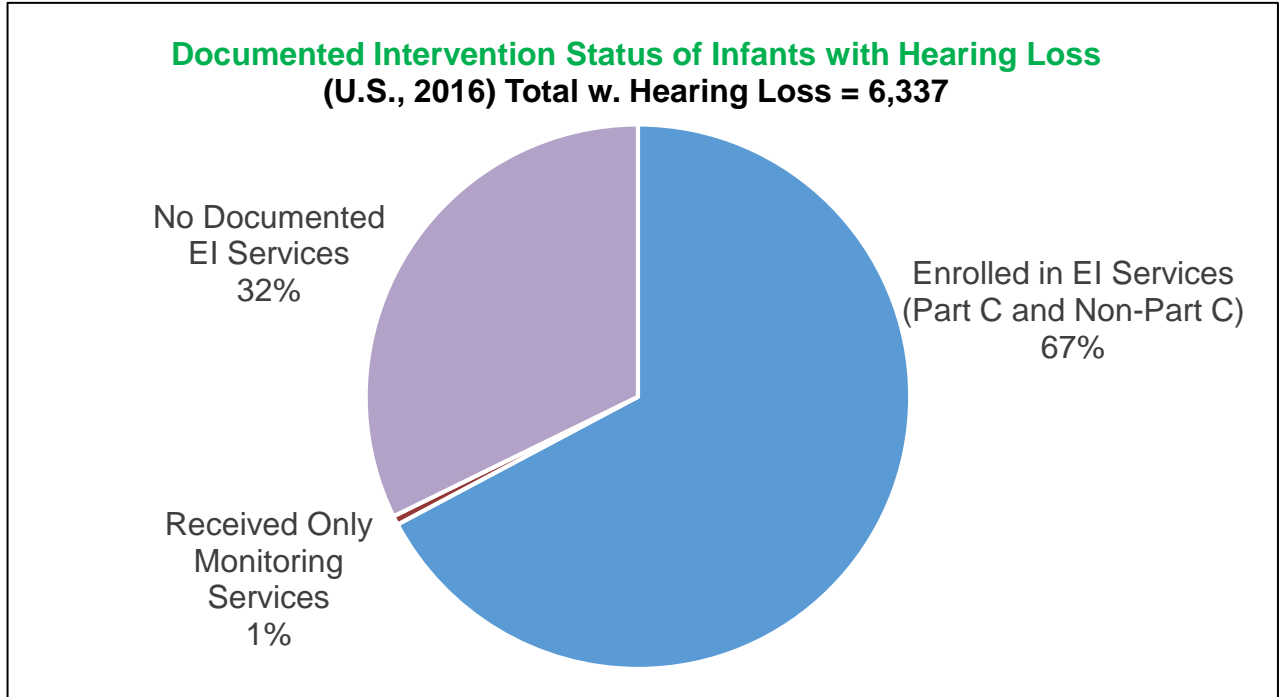

Data Notes

- HSFS data reflects information that states and territories have reportedly **documented** without estimation. As a result, data reported by CDC EHDI may differ from other sources.
- Some respondents only provided partial data (e.g. hearing screening data only). As a result, the number of reporting states and territories and denominators varies for some of the data sections.
- This data is subject to change if additional states and/or territories report data for year 2016.
- **In Process:** Respondents were advised that to be reported in this category each infant must have been seen for diagnostic testing at least one time and have a follow-up appointment already scheduled.
- **LFU (Loss to Follow-up) / LTD (Loss to Documentation):** Sub group of “No Documented Diagnosis / Undetermined” and “No Intervention Services / Undetermined.” Includes cases where infant’s families were *contacted but unresponsive, unable to be contact, and unknown.*
