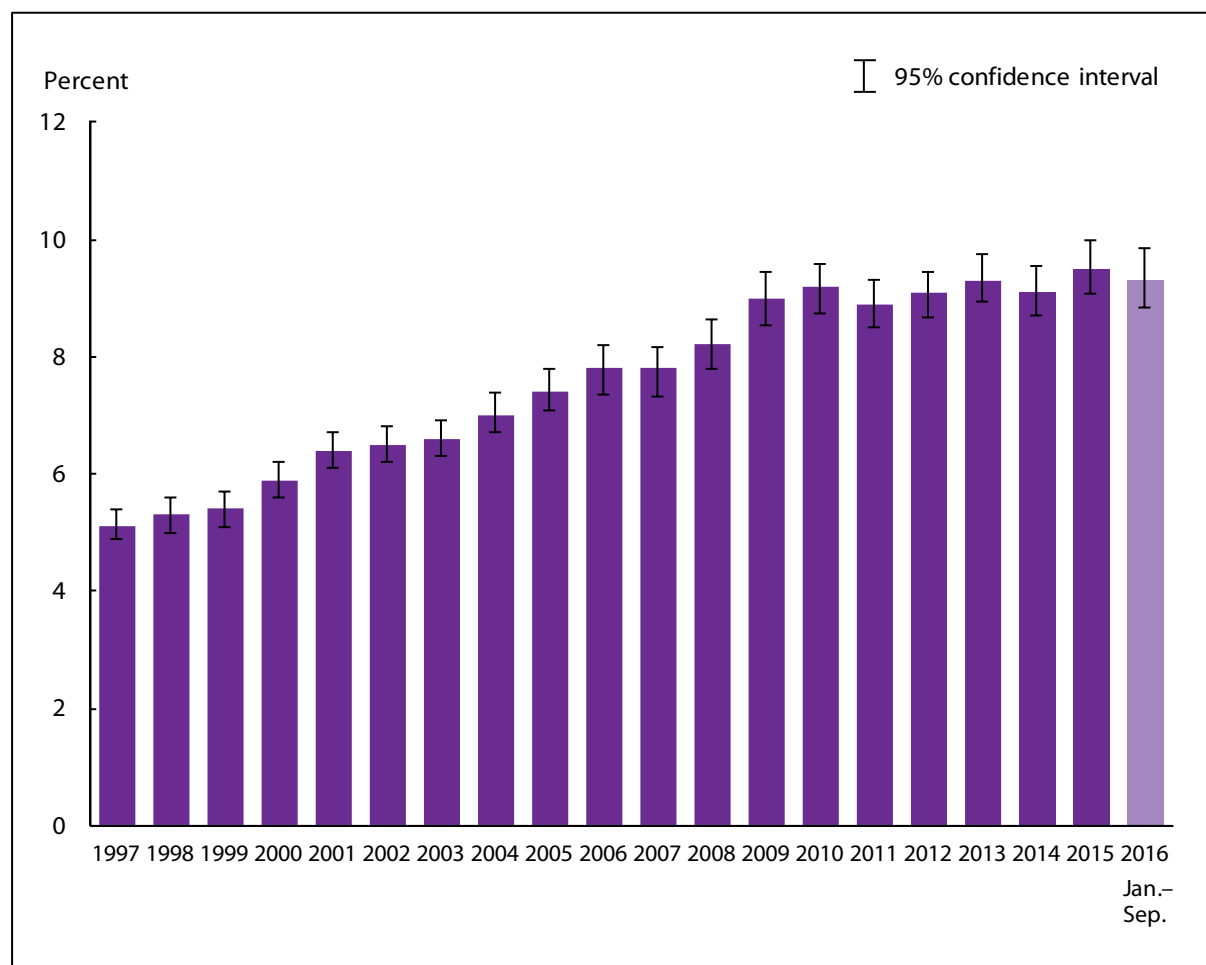


Diagnosed diabetes

Figure 14.1. Prevalence of diagnosed diabetes among adults aged 18 and over: United States, 1997–September 2016

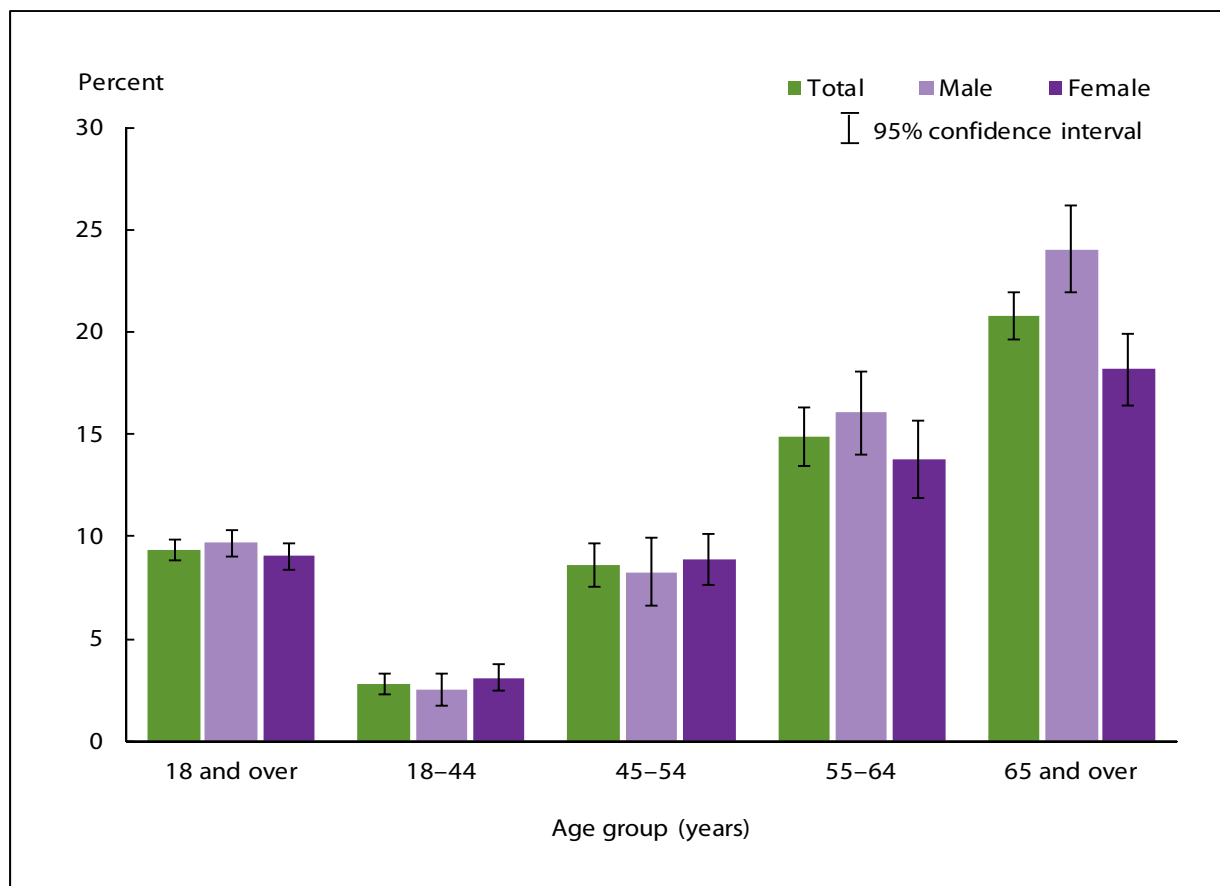

Prevalence of diagnosed diabetes is based on self-report of ever having been diagnosed with diabetes by a doctor or other health professional. Persons reporting “borderline” diabetes status and women reporting diabetes only during pregnancy were not coded as having diabetes in the analyses. - For January–September 2016, 9.3% (95% confidence interval = 8.83%–9.87%) of adults aged 18 and over have been diagnosed with diabetes. This percentage was not significantly different from the 2015 estimate of 9.5%.
- The prevalence of diagnosed diabetes among adults aged 18 and over increased, from 5.1% in 1997 to 9.2% in 2010, and has since remained stable through 2015.

Figure 14.2. Prevalence of diagnosed diabetes among adults aged 18 and over, by age group and sex: United States, January–September 2016

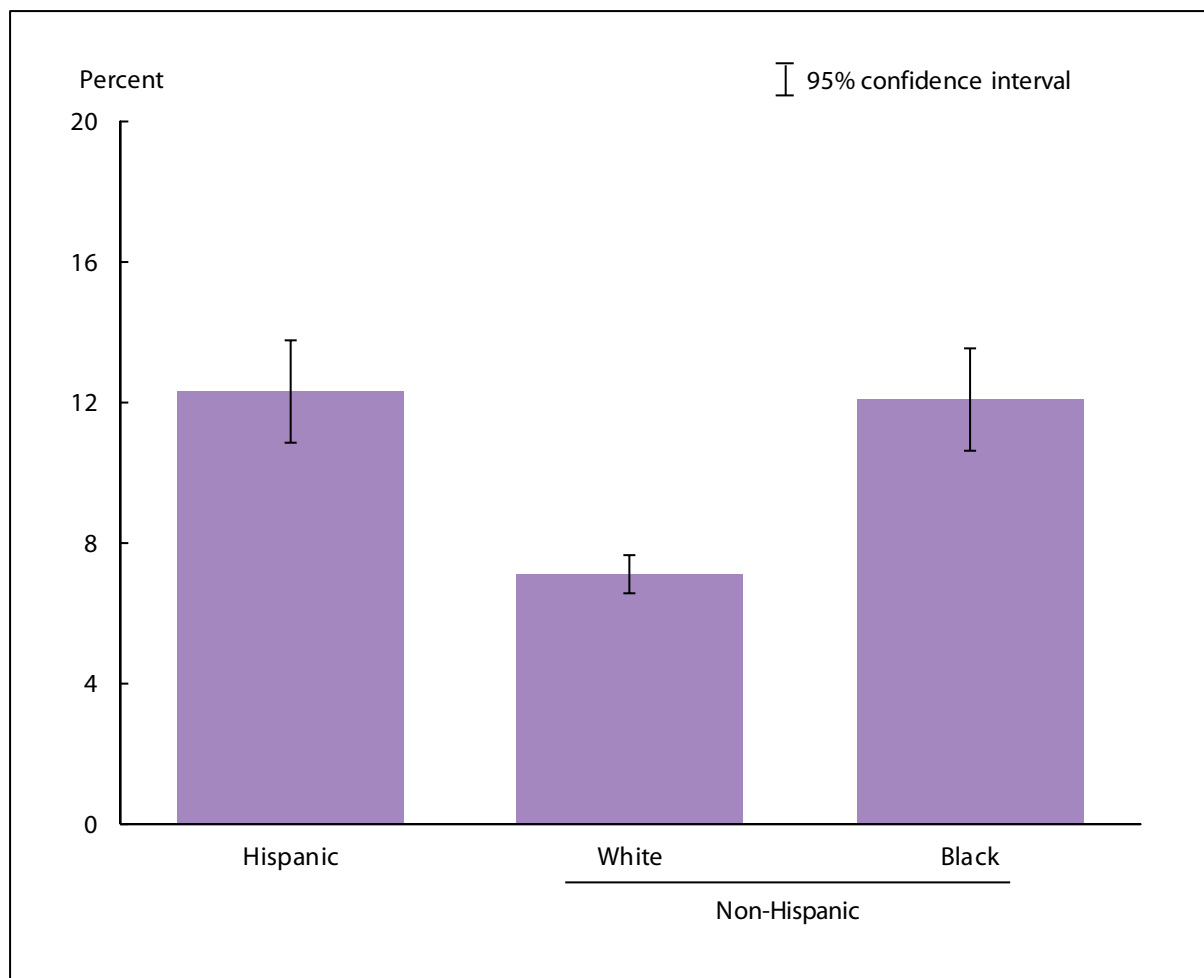

- For both sexes combined, the prevalence of diagnosed diabetes increased with age. Adults aged 65 and over (20.8%) were more than seven times as likely as those aged 18–44 (2.8%) to have been diagnosed with diabetes. Men aged 65 and over (24.0%) were more than nine times as likely as men aged 18–44 (2.5%) to have been diagnosed with diabetes, while women aged 65 and over (18.2%) were more than five times as likely as women aged 18–44 (3.1%) to have been diagnosed with diabetes.
- For adults aged 65 and over, women were less likely than men to have been diagnosed with diabetes.

- The age-sex-adjusted prevalence of diagnosed diabetes was 12.3% for Hispanic adults, 7.1% for non-Hispanic white adults, and 12.1% for non-Hispanic black adults.
- The prevalence of diagnosed diabetes was lower among non-Hispanic white adults compared with Hispanic adults and non-Hispanic black adults.
