The primary purpose of this document is to provide Web/CATI programming specifications that outline the question and response option wording, variable names, variable types (e.g., single response, multi-check), response values, universe/skip logic, allowable numeric ranges, text character limits, error messages, and other necessary instructions for formatting (e.g., items per page). Programming instructions are presented in all caps in brackets and use green text. Respondent facing text is shown in black. Programming specifications for RSS-4 are as follows:
