

Purpose of today's webinar

- On December 31, 2022, the TeleTracking contract will expire, and reporting will transition to NHSN
- Review of steps to prepare for the transition
 - Facility Enrollment
 - NHSN Access
 - NHSN OrgID Verification
 - NHSN Groups
- Transition preparation will be ongoing with additional webinars, standing meetings, and frequent webpage updates

Important Information

- Reminder that reporting activities will not change until mid-December 2022
 - Continue reporting as usual
- There will be <u>no impact or changes</u> to reporting for the LTCF, Dialysis, and Healthcare Personnel Vaccination COVID-19 modules in NHSN

Important Information (continued)

- There will be no significant changes to the reporting questions as result of this transition
- Process for reporting will remain the same
 - Hospitals will still be able to report individually
 - Hospital systems will still be able to report centrally at an enterprise level
 - Jurisdictions will still be able to report on behalf of their facilities
 - Third party vendors will still be able to report on behalf of facilities and/or jurisdictions
- Reporting capabilities for web interface, CSV upload, and API will remain the same
- Data will still be aggregated into HHS Protect
 - Historical data will still be fully available within HHS Protect

Timeline and Important Dates

- October 1, 2022 (recommended)
 - Obtain access/active user in NHSN
- Late October 2022 mid-December 2022
 - Module available in NHSN for data submission testing
- Mid-December 2022
 - Reporting transition

About NHSN

- NHSN is a vendor-neutral, standards-based surveillance program
- NHSN collects and analyzes healthcare-associated infection data
- The system has more than 130,000 users (often in the infection control department) in more than 38,000 healthcare facilities nationwide
 - Hospitals, nursing homes, dialysis facilities, ambulatory surgical centers
- Since the start of COVID-19 CDC has received resources to modernize public health data collection
 - CDC is working to modernize and improve many of its public health surveillance systems, including NHSN

Transition Preparation Key Questions – Facilities

- Is my facility enrolled in NHSN?
- How will my facility report?
 - Manual entry
 - CSV upload
 - Via larger organization (health system corporate office, state health department, or third-party vendor)
- Is there a current NHSN user to submit the hospital COVID-19 data?
- Is my NHSN OrgID entered correctly in the current reporting system?



NHSN Access – Facility-level Users

- If submitting for the individual hospital/facility via manual webform entry or CSV upload:
 - Identify user(s) in the facility who will be submitting hospital
 COVID-19 data
 - Ensure user(s) have access to the NHSN Patient Safety Component
 COVID-19 module
 - Access to COVID-19 module with Custom Rights



Facility Enrollment

- Important: Most hospitals are already enrolled in NHSN
- Please do not begin enrolling a <u>facility</u> without confirmation from NHSN that enrollment is needed
- How do I know if my facility is enrolled?
 - Am I Enrolled? (AMIE)
 - Website form
 - Available end of September
 - Contact the facility infection prevention and control department

NHSN Enrollment (as of August 18, 2022):

7,148 Hospitals (this includes 444 Long-term Acute Care Hospitals, 433 Free-standing Inpatient Rehabilitation Facilities, and 810 Inpatient Psychiatric Facilities)

7,928 Outpatient Hemodialysis Facilities

5,431 Ambulatory Surgery Centers (ASCs)

17,864 Long-term Care Facilities

38,371 Total Healthcare Facilities Enrolled



NHSN Access

- The NHSN Facility Administrator or NHSN user can:
 - Confirm facility enrollment in NHSN
 - Add new users to the NHSN application
 - How to Add A New NHSN User: https://www.cdc.gov/nhsn/pdfs/Add-User-508.pdf
- Contact facility infection prevention and control department
- If unable to identify an NHSN user at the facility
 - Email <u>NHSN@cdc.gov</u> and provide the following
 - Email subject line: "COVID-19 Hospital"
 - Facility name
 - Facility address (including zip code)
 - CCN (if applicable)



NHSN Access

- New NHSN user added to a facility
 - Receive "Welcome to NHSN!" email
 - 2. Accept NHSN Rules of Behavior
 - 3. Receive Invitation to Register with SAMS
 - 4. Complete Identity Verification



SAMS (Secure Access Management Services)

- Invitation to Register with SAMS email
- Link to the SAMS registration page with email address and a temporary password
 - Important: Ensure you use the same email address when completing SAMS registration
- After receiving the SAMS invitation email, you have 30 days to complete registration
- Identify Proofing Verification: Experian online method



Transition Preparation

NHSN OrgID Verification



What is the NHSN OrgID?

(Organization Identification Number)

- Also called the NHSN Facility ID
- Automatically assigned when a facility enrolls into NHSN
- Unique numeric identifier in the NHSN application
- The NHSN OrgID must be provided for data to be accurately matched to the correct facility
- Facility names and addresses can be duplicative, and other identifiers such as CMS certification number (CCN) can be used by more than one individual facility



NHSN OrgID Verification

- NHSN is currently working with entities (states, vendors, etc.) reporting on behalf of facilities to ensure they have the correct NHSN OrgIDs
- Facilities will also need to work with entities reporting on their behalf to review and verify the NHSN OrgID
- Facilities reporting individually should know their NHSN OrgID

What if I do not know where to find the NHSN OrgID?

- Contact the facility infection prevention and control department
- Facilities enrolled in NHSN have a NHSN Facility Administrator or NHSN user with access to the OrgID
- If unable to contact an NHSN Facility Administrator or user, please email NHSN@cdc.gov and provide the following information:
 - Email subject line: "COVID Hospital Data NHSN Facility Identifier"
 - Facility name
 - Facility address (including zip code)
 - CCN (if applicable)

Transition Preparation

Group Reporting/Bulk Uploaders



NHSN Group Function

 Allows facilities to share data with larger organizations (health departments, corporate health systems, and/or third-party vendors)

- Many Groups are already set up in NHSN
 - For example, all State Health Departments have NHSN Groups



Group Reporting/Bulk Uploading Key Questions

- Is there an existing Group in NHSN?
- Do additional facilities need to be added to an existing Group?
- What data can Group users view, upload, edit, analyze in NHSN?
 - COVID-19 module

Group Reporting/Bulk Uploading Transition

- NHSN will be in touch with reporting entities that are currently reporting data on behalf of facilities
 - One-on-one conversations to sort through the specific of each of their reporting practices
 - Ensure NHSN Groups set-up, access for appropriate users
 - Scheduled calls with state health departments, state HAI coordinators, and vendors
