Program News

- **DCAS updates**
 - **September 25-26 NIOSH-sponsored Dose Reconstruction (DR) and SEC workshop in Cincinnati**
 - **November 6-8 NIOSH Ombudsman-sponsored workshop on EEOICPA for advocates**

Overall Initial Claim Information

(as of November 30, 2012)

- 38,401 cases have been referred to NIOSH for dose reconstruction
- 36,252 (94%) cases have been returned to DOL
 - Cases submitted with a DR report **31,794**
 - Cases currently pulled from DR by DOL **1,258**
 - Cases currently pulled from DR for SEC **3,200**
- 1,496 (4%) cases remained at NIOSH for dose reconstruction
- 653 (2%) cases were administratively closed

Overview of Active Cases

(as of November 30, 2012)

- **Of the 1,496 cases remaining at NIOSH for dose reconstruction:**
 - **329 cases in the dose reconstruction process**
 - **247 initial draft dose reconstruction reports in the hands of claimants, and NIOSH awaiting the return of the OCAS-1 form**
 - **920 cases in development to begin the dose reconstruction**

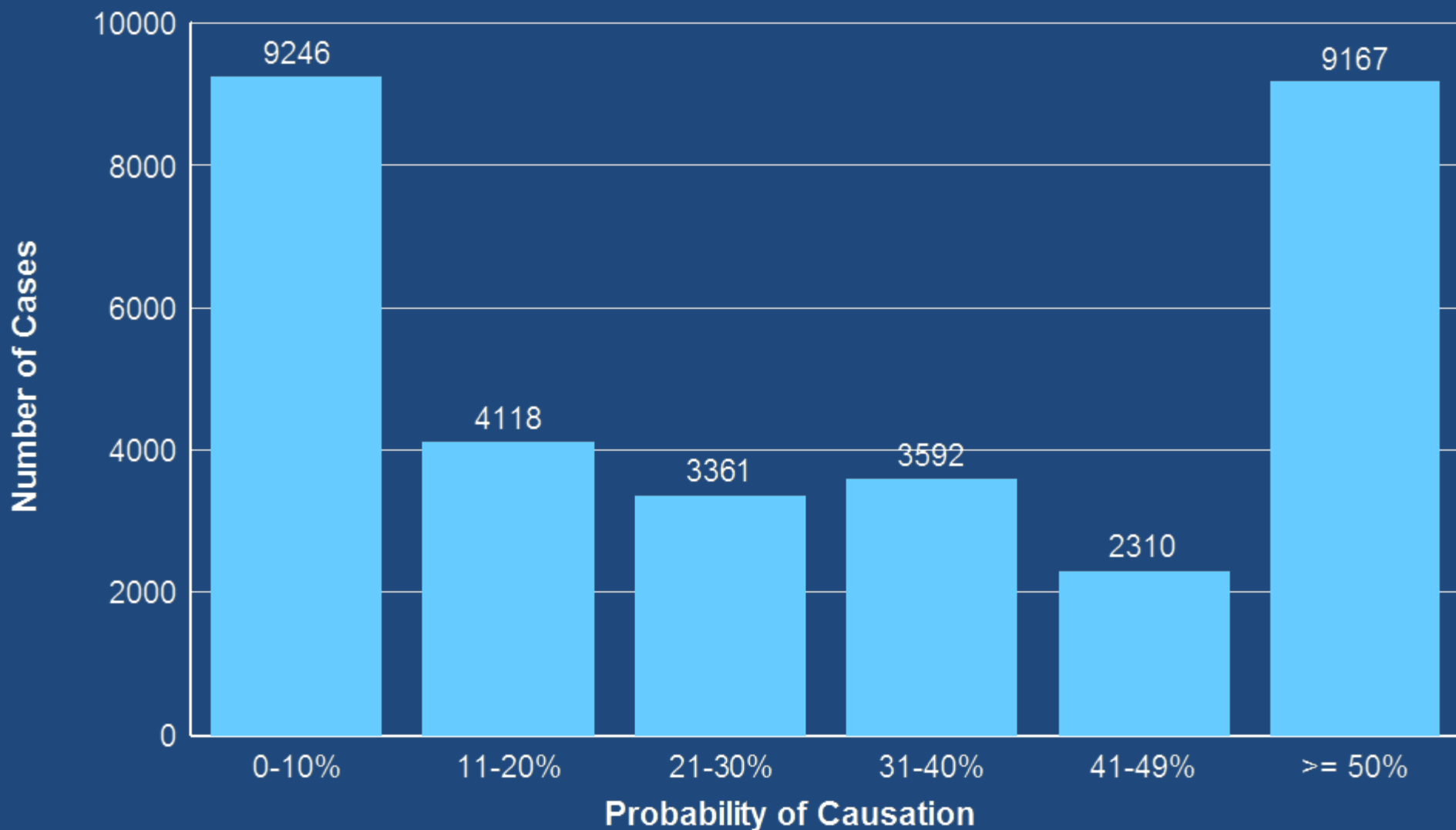
Summary of PoCs for Completed Dose Reconstructions

(as of November 30, 2012)

- Of the 31,794 dose reconstructions sent back to DOL for final adjudication:
 - 22,627 cases had a PoC \geq 50%
 - 9,167 cases had a PoC $<$ 50%

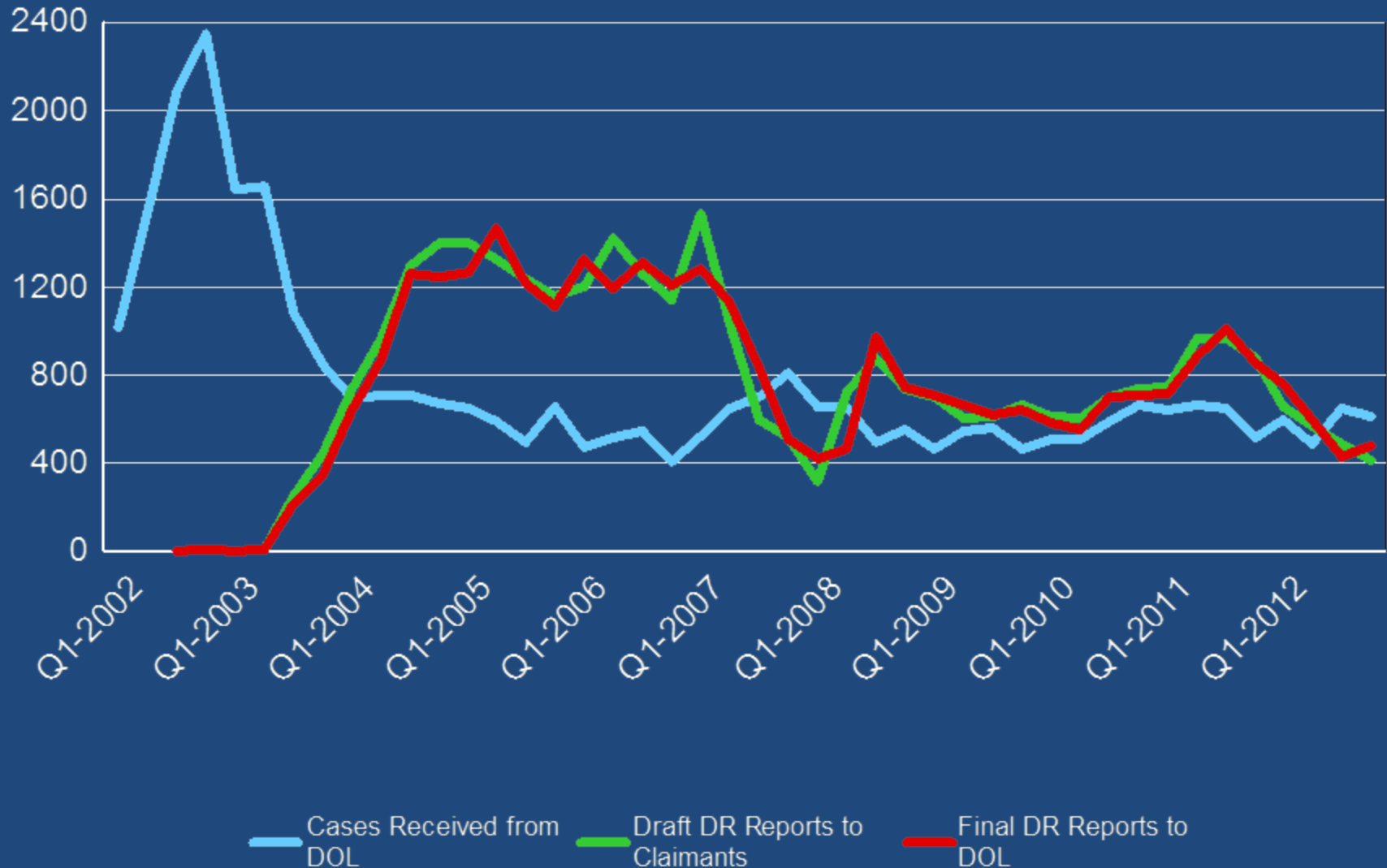
Distribution of PoC for Cases Sent to DOL

Status of First 5,000 Claims

(as of November 30, 2012)

- **4,870 claims at DOL**
 - 273 pulled for DOL issues
 - 390 pulled for SEC
 - 4,207 submitted with DR

- **111 claims at NIOSH**
 - 83 admin closed
 - 1 DRs with claimants (DOL reworks/reinstated within past year)
 - 17 DRs in process (DOL reworks/reinstated within past year)
 - 10 gathering information

- **19 claim numbers deleted**

Status of First 10,000 Claims

(as of November 30, 2012)

- **9767 claims at DOL**
 - 448 pulled for DOL issues
 - 1017 pulled for SEC
 - 8,302 submitted with DR

- **203 claims at NIOSH**
 - 151 admin closed
 - 7 DRs with claimants (0 initial; 7 DOL reworks within past year)
 - 33 DRs in process (3 initial; 30 DOL reworks within past year)
 - 12 gathering information

- **30 claim numbers deleted**

DOE Response to Requests for Exposure Records

(as of November 30, 2012)

- Number of outstanding requests 346
- Outstanding requests > 60 days 65

(as of November 30, 2012)

Special Exposure Cohort Summary

(as of November 30, 2012)

- 95 SEC classes have been added since May 2005
 - 53 (56%) through the 83.13 process
 - 42 (44%) through the 83.14 process
- 15 SEC classes have been denied since May 2005
- 3 SEC classes are under HHS admin review
- Represents classes of workers from 68 sites
- Represents 4,180 potential claims
