CDCREC 1.3 Background & Purpose

 - Aligns with OMB SPD-15 Revision 30 Oct 1997.
- Race Category Updated
 - American Indian or Alaska Native (AIAN)
- CDCREC 1.3 AIAN Update Data Source
 - U.S. Census Bureau (USCB) 2020 decennial census redistricting file, appendix F, Hispanic origin and race code list (2020 Census National Redistricting Data Summary File)

CDCREC 1.3 Background & Purpose

• Changes in CDCREC 1.3

- Added Bureau of Indian Affair (BIA) federal recognition status to AIAN concept.
- Added CDCREC 1.2 to 1.3 mapping table.
- Added reclassified concept table.
- Added retired concept table.
- Adopted BIA's federally recognized tribal name as CDCREC 1.3 full concept name
- Adopted BIA's tribal directory short name as CDCREC 1.3 preferred concept
- Added Somali concept for Black or African American category

CDCREC 1.2 to 1.3 Mapping Logic and Definition

- Reclassified Concept Definition
 - Minor change in concept description, but essentially the same concept, or concept's hierarchy level or grouper concept is changed. It is considered reclassified concept, and the same concept code is carried over to CDCREC 1.3
- Reclassified Concept Example
 - Example 1: Eastern Cherokee (1092-6) was reclassified to a similar tribe name of Eastern Band of Cherokee Indians. The 1092-6 concept code was carried over to CDCREC 1.3 and listed under reclassified concept table.
 - Example 2: In CDCREC 1.2 Mexican American Indian (1072-8) was classified under the Canadian and Latin American Indian (1068-6) grouper. In CDCREC 1.3 Mexican American Indian (1072-8) is now reclassified under a new grouper, Latin American Indian (4085-7). There was no change for the Mexican American Indian (1072-8) concept name and code and is listed under reclassified concept table.

CDCREC 1.2 to 1.3 Mapping Logic and Definition

- Retired Concept Definition
 - Concept is no longer useful and rendered inactive. Merger or split of the concept make it no longer useful. Hence, the concept is retired. If a new concept is created for a retired concept, the new concept name and new concept code is documented in the retired concept table.
- Retired Concept Example
 - Example 1: Western Cherokee (1098-3) concept was retired and was mapped to a completely new concept, Cherokee Nation, and a new code (3080-9) was created
 - Example 2: Canadian and Latin American Indian grouper concept (1068-6) was split to two different grouper concepts, Canadian Indian(1069-4), and Latin American Indian(4085-7). The 1068-6 grouper concept is no longer useful. The 1068-6 concept code is retired and documented in retired concept table.

Ambiguous Concept Mapping Issue

Fuzzy Concept Mapping Challenge

- Pima (1456-3) and Maricopa (1728-5) concepts are in CDCREC 1.2.
- Difficult to identify which CDCREC 1.3 concept that Pima (1456-3) or Maricopa (1728-5) should be mapped because two concepts, Gila River Pima-Maricopa (1457-1) and Salt River Pima-Maricopa Indian Community (1458-9) contains Pima and Maricopa in the concept name.

Resolution

- Retired Gila River Pima-Maricopa (1457-1), not in 2020 census code list
- Created new concept code for (3174-0) Gila River Indian Community of the Gila River Indian Reservation
- Mapped Pima (1456-3) and Maricopa (1728-5) to their respective codes and concepts in CDCREC 1.3
